PROFILE

Winnipeg is a city of many cultures of which the Chinese community has always been an integral and significant part. Over the last few decades, as the number of Chinese immigrants increased, so has the need for redeveloping Winnipeg's Chinatown.

In 1981, the redevelopment became a reality with the support of the three levels of government through the Winnipeg Core Area Initiative and the Chinese community itself. The Winnipeg Chinatown Corporation was established in 1981, and in 1983 the Winnipeg Chinese Cultural and Community Centre was incorporated as part the overall development project in response to a survey conducted in 1982 wherein 90% of the Chinese in Winnipeg indicated a need for such a facility.

OBJECTIVES

- To promote and advance the awareness, knowledge and appreciation of the Chinese culture in relation to the multi-cultural mosaic of Winnipeg, Manitoba and Canada.
- To increase understanding between the various Chinese and non-Chinese organizations in Manitoba.
- To encourage public understanding of matters relating to the affairs of the Chinese Community.
- To provide facilities for educational, cultural and recreational purposes.

PRESIDENT REPORT

At this AGM,I am pleased to report that 2004 has been another active and successful year. As well, the beginning of the 2005 has been very challenging and exciting for the Winnipeg Chinese Cultural and Community Centre(WCCCC).

Once again, Foiklorama-Chinese Pavilion was exceptional popular and successful primarily due to the great efforts of the volunteers and the astonishing performance of the Beijing Golden Sail Folk Art Troupe from China. There were more than 6000 persons visited the Chinese Pavilion during the week of August 1 to 7, 2004.

On June 15, 2004, a ten members television crew from the Shanghai Oriental Television visited Winnipeg at the invitation of the Manitoba Cultural, Heritage and Tourism. Winnipeg Chinatown, the Chinese Cultural Centre and Chinese railroad worker sculpture at the Leo Mol garden were the main component of the film production in Manitoba. This unique cultural and Travel TV series entitled, "Driving Across Canada-from coast to coast" was televised in China and Canada in October 2004 and well received.

As President of WCCCC, I am exceedingly proud to the joint efforts with B'nai Brith Canada to present the Winnipeg Premier of the National Film Board documentary "In the Shadow of Gold Mountain" at the Winnipeg Art Gallery on November 23, 2004. This compelling documentary of the Chinese Head tax and Exclusion Act written and directed by a young film maker, Karen Cho from Montreal, was illuminating and inspiring for the audience to re-think and re-examine this important and seemingly forgotten history.

2004 also saw an important expansion to our long and mutual beneficial relationship with the Winnipeg Foundation. The Foundation has agreed to administer a trust fund for the benefit of the Chinese community in Winnipeg. By establishing this "Winnipeg Chinese Community Foundation"endowment fund through the Winnipeg Foundation, administration costs are kept to the bare minimum, and to maximizing the good-works that can be done with the money. The fund, which will support the long-term viability of WCCCC and its programs, has already raised a significant amount of money, but more is needed. We plan to kick-off the official campaign by requesting The Lieutenant Governor of Manitoba, His Honour John Harvard to host a lunch at the Government House in May this year.

To kick-off the celebration of 2005, WCCCC Co-hosted a jubilant folk art performing evening with the Manitoba Great Wall Performing Arts Inc. in January at the Pantages Playhouse Theatre. This celebrating event was performed by the very talented local Chinese performing troupe with guest performers from the Ukraine Rusalka Dance group.

As you all know, Tsunami disaster touched the heart of everyone in the world. The WCCCC was able to rally the Chinese Community in a short time period to organize a fundraising dinner at Kum Koon Garden on February 1, 2005. Thanks to the

overwhelmingly response from the community, we raised over \$10,000 for the Red Cross to distribute to the Tsunami victims.

Again this year, in conjunction with the Chinese Benevolent Association, we sponsored a Chinese New Year's banquet in the Kum Koon Garden to celebrate the year of the rooster on February 9. The event was an enormous success with over seven hundred attendees and for the first time, CBC television broadcasted live from the banquet at its "Canada Now" prime time program. The banquet as well as the story of the traditional Chinese New Year celebration; the retaining and promoting the Chinese language and culture in Canada; and the story of students from China and Canadians adopted Chinese orphans were prominently featured.

As Spring is gradually approaching, the Centre is actively planning two projects to be held in the Summer and Fall in 2005. After the successful joint venture Summer Camp in China in 2000. The Beijing Song Ching Ling Foundation has once again invited WCCCC to Co-organize an International Summer camp in China sometime in August this year. Application to join this worthwhile and exciting trip will be announced once the Song Ching Ling Foundation provide us with the details. On November 10, 2005, the WCCCC will host its biennial fundraising gala at the Winnipeg Convention Centre. This year, two outstanding Manitobans will be honored: The Honourable Reg Alcock, M.P., Winnipeg South, Treasury Board President, Minister Responsible for the Wheat Board and Senior Minister for Manitoba, and Mr.Raymond Wan, a prominent architect who has made significant contribution to the Redevelopment of Chinatown project.

In conclusion, I would like to thank the board of directors and in particular, the staff and volunteers for their great efforts and dedication. The Cultural Centre's success is entirely due to their energy and devotion. Sadly, I have to report the departure of Art Miki and Justice Scott Wright from our Board. Art has been on our board for a number of years and has been a valuable member of WCCCC, Justice Scott has been involved with WCCCC for more than a decade. His dedication and enthusiasm toward WCCCC and the Chinese community is greatly appreciated.

In order to succeed high caliber and dedicated individuals such as Art Miki and Justice Scott, we are trying hard to recruit people from diverse background and disciplines to serve our board and the community. Fortunately, Professor Gong from University of Manitoba and Mr. Allan Yusim from B'nai Brith Canada have accepted nomination to be elected as board of directors at this AGM. I want to thank them for their interest and look forward to working with them.

Let's work together to meet our challenges and opportunities in years ahead. Thank you.

- 6. Nov 27/04 Mr Jordan Lee-Wing, a lawyer, being our guest speaker, gave us a friendly and informative talk about the new law and right of same sex marriage. He also answered a lot of legal questions and concerns on other issues. We were all very thankful for his time.
- 7. Dec 19/04 We had a happy Christmas dinner at Dim Sum Garden.
- 8. Jan 23/05 A health talk about safety use of medicine was given by Maria Lip.

We had been doing fund raising by selling show and save cards semi-annually. This group of women come to the meeting faithfully in order to obtain updated information about health promotion and self care.

ENGLISH FOR SENIORS PROGRAMME 2004 – 2005



The Winnipeg Chinese Cultural and Community Centre (WCCCC) supports the very successful English as a Second Language (English for Seniors) programme run by Age and Opportunity (A&O). The Manager of the Programme is Lan Doan.

This ESL programme is designed to help people who are fifty-five years of age and above and who are formerly from overseas to learn English. The aim is to help these Canadian Residents integrate into our multilingual and multicultural society. By learning one of Canada's two official languages they will be able to benefit from the many social services available to aid Senior Citizens as they become in need of support.

There are three (3) classes supported by the WCCCC which are run at two (2) locations:

- Smith Street Senior Centre: 185, Smith Street in Downtown Winnipeg. (Morning class)
 - At this Centre, during the fiscal year 2004-2005, a Beginner/Intermediate class was run. Kathy Sawatsky teaches a class average of sixteen (16) Beginner/Intermediate students on Tuesdays and Fridays.
- 2. Smith Street Senior Centre: 185, Smith Street in Downtown Winnipeg.
 (Afternoon class)
 At this Centre, during the fiscal year 2004-2005, a Beginner/Intermediate class was run.
 Theresa, Dong, teaches, a class, average, of course towards (20), R. i.e., G. i.e., G.
 - Theresa Dong teaches a class average of some twenty (20) Beginner/Intermediate students on Tuesdays and Wednesdays.
- Age and Opportunity Head Office, 200-283 Portage Avenue in Downtown Winnipeg. (Morning class)
 - At this location, during the fiscal year 2004-2005, an Advanced class was run. Shannon MacFarlane teaches a class average of fifteen (15) students on Tuesdays and Fridays.

All participants enjoy a variety of activities. These include visiting speakers representing a variety of interests such as talks by the Winnipeg Police, Fire and Paramedic Services, Citizenship and Immigration Services etc. Practical lessons are conducted in English outside the classroom in such topics as travelling on public transport and shopping in supermarkets. Visits are also made to public buildings such as the Manitoba Museum, the Government Mint and the Art Gallery in Assiniboine Park. These lessons encourage students to meet people in situations they are likely to encounter in their daily lives. This helps them integrate into society as a whole. It also encourages them to use their newly acquired language skills whereby they learn more about Canada, make new friends and enjoy an enhanced quality of life. Of the more than fifty (50) students in both locations, most have come from China and Vietnam but are joined by students from Russia, Eastern Europe, Africa, the Indian sub-continent and the Middle East.

Folklorama2004 Chinese Pavilion Beijing Golden Sail

Folklorama is referred as the festival of Nation. It is a festival truly representative of one nation of Canada. Through food, entertainment, and cultural displays, Winnipeg Folklorama presents one of the best multicultural events that Canada has to offer.

"A summer night with Beijing Golden Sail" was the opening ceremony of Chinese Pavilion for Folklorama in 2005, which was hold in the Pantages Playhouse Theatre in July 30, 2004. More than 1300 audiences attended including Mayor Sam Katz, Deputy Consul General Mr. Li Zhengming, former General Governor of Canada etc.. China Centre Television also sent a director and a reporter to report this big event and a 30 minutes video will be broadcast in China.

From August 1 to August 7, 2005, BGS had 21 shows in Chinese Pavilion, 3 in each day. Over 10,000 visitors of different races were attracted to Chinese Pavilion and enjoyed the wonderful Chinese cultural display.

Besides the splendid show, we also have some highlight of our outstanding Ambassadors. Dr. Tina Chen was awarded the Female Ambassador General in 2005. We have delicious Chinese food service, we have wonderful souvenir as well as the amazing lion dance and Chinese Martial Arts display. The concrete result of this project has been enormous since it attracts over 6000 visitors to enjoy and appreciate the Chinese Cultural annually during this oneweek event. Furthermore, it also attracts over 100 volunteers to work in harmony and tirelessly at

AUDITORS' REPORT

To the Members of Winnipeg Chinese Cultural and Community Centre Corporation

We have audited the statement of financial position of Winnipeg Chinese Cultural and Community Centre Corporation as at March 31, 2004 and the statements of changes in fund balances, operations and cash flows for the year then ended. These financial statements are the responsibility of the corporation's management. Our responsibility is to express an opinion on these financial statements based on our audit.

Except as explained in the following paragraph, we conducted our audit in accordance with Canadian generally accepted auditing standards. Those standards require that we plan and perform an audit to obtain reasonable assurance whether the financial statements are free of material misstatement. An audit includes examining, on a test basis, evidence supporting the amounts and disclosures in the financial statements. An audit also includes assessing the accounting principles used and significant estimates made by management, as well as evaluating the overall financial statement presentation.

In common with many charitable organizations, the corporation derives revenue from fundraising activities and donations, the completeness of which is not susceptible of satisfactory audit verification. Accordingly, our verification of these revenues and expenditures was limited to the amounts recorded in the records of the corporation and we were not able to determine whether any adjustments might be necessary to fund-raising revenue and expenses, donation revenue, excess revenues (expenses), assets and fund balances.

In our opinion, except for the effect of any adjustments, if any, which we might have determined to be necessary had we been able to satisfy ourselves concerning the completeness of the fund-raising and donation revenue referred to in the preceding paragraph, these financial statements present fairly, in all material respects, the financial position of the corporation as at March 31, 2004 and the results of its operations and the changes in its cash flows for the year then ended, in accordance with Canadian generally accepted accounting principles.

NOTES TO FINANCIAL STATEMENTS MARCH 31, 2004

NATURE OF THE ORGANIZATION

The corporation is a non-profit, non-partisan and non-sectarian entity incorporated under The Corporations Act of Manitoba. It is a registered charity within the meaning of the Income Tax Act and is therefore exempt from income taxes and may issue income tax receipts to donors.

The purpose of the corporation is to promote and advance the knowledge and appreciation of Chinese culture in relation to the multicultural mosaic of Manitoba and Canada; to construct, hold, manage, provide and maintain a Cultural Centre; to increase understanding between Chinese organizations in Manitoba; and to encourage public understanding of matters relating to the affairs of the Chinese community.

2. SIGNIFICANT ACCOUNTING POLICIES

The financial statements of the corporation have been prepared in accordance with Canadian generally accepted accounting principles. Because a precise determination of many assets and liabilities is dependent upon future events, the preparation of financial statements for a period necessarily involves the use of estimates which have been made using careful judgement. The financial statements have, in management's opinion, been properly prepared within reasonable limits of materiality and within the framework of the significant accounting policies summarized below:

(a) Fund Accounting

These financial statements were prepared using the accrual basis of accounting.

The corporation follows the deferral method of accounting for contributions.

Revenues and expenses related to program delivery and administrative activities are reported in the Operating Fund.

The Capital Fund reports the assets, liabilities, revenues and expenses related to the organization's capital assets and building expansion campaign.

NOTES TO FINANCIAL STATEMENTS MARCH 31, 2004

2. SIGNIFICANT ACCOUNTING POLICIES, continued

(b) Capital Assets

Donated capital assets are recorded at fair market value. Purchased capital assets are stated at cost. The capital assets are amortized over their estimated useful life using the declining balance method as follows:

Building and building improvements	5%
Computer equipment	30%
Equipment under capital lease	10%
Furniture, fixtures and equipment	10%
Leasehold improvements	10%

Amortization is recorded in the Capital Fund.

(c) Deferred Grants

The deferred grants were received during 1987 to 1990 for the construction of the Cultural Centre. These grants are being amortized into revenue on the same basis that the amortization of the building is being charged to expenses; that is, on the declining balance method at a rate of 5% per annum.

(d) Revenue Recognition

Restricted contributions are recognized as revenue of the appropriate fund in the year in which the related expenses are incurred. Unrestricted contributions are recognized as revenue of the appropriate fund when received or receivable if the amount to be received can be reasonably estimated and collection is reasonably assured.

Restricted investment income is recognized as revenue of the appropriate fund in the year in which the related expenses are incurred. Unrestricted investment income is recognized as revenue when earned.

(e) Contributed Materials and Services

Contributed materials which are used in the normal course of the corporation's operation and would otherwise have been purchased, are recorded at their fair value at the date of contribution if fair value can be reasonably estimated. Volunteers contribute a significant number of hours annually to assist the corporation in carrying out its service delivery activities. Because of the difficulty of determining their fair value, contributed services are not recognized in the financial statements.

4. LEASE AGREEMENTS

- (a) The City of Winnipeg has subleased to the corporation air rights over the land on which the Cultural Centre is located for a period of 98 years expiring March 2, 2083. The rent under the sublease agreement is \$1 per year fully payable in advance.
- (b) The corporation has subleased to Maritime Life Assurance Company and Montrose Mortgage Corporation Ltd. ("Owners") the air rights over the land on which the Cultural Centre is located for the period January 1, 1987 to March 1, 2083. The rent receivable under the sublease is 8½% of the annual "Net Revenue".
- (c) The Owners have subleased to the corporation the second floor of the Dynasty Building for the period January 1, 1987 to July 31, 2083. The rent payable to the Owners under the sublease is as follows:
 - (i) \$1 per year in advance; and
 - (ii) the corporation's proportionate share of the operating costs and taxes of the Dynasty Building (as defined in the sublease agreement); and
 - (iii) an administration fee of 15% of the above-mentioned operating costs.

4. LEASE AGREEMENTS, continued

During the previous year, the corporation reached a settlement with its lessor regarding disputed rental charges. The settlement was subject to approval from the City of Winnipeg and the Province of Manitoba. This approval was received during the current year.

As a result, accounts payable has been decreased by \$241,524 and forgiveness of debt revenue in the same amount has been recorded.
